- 1.15 pm: Malanotte del Piave DOCG

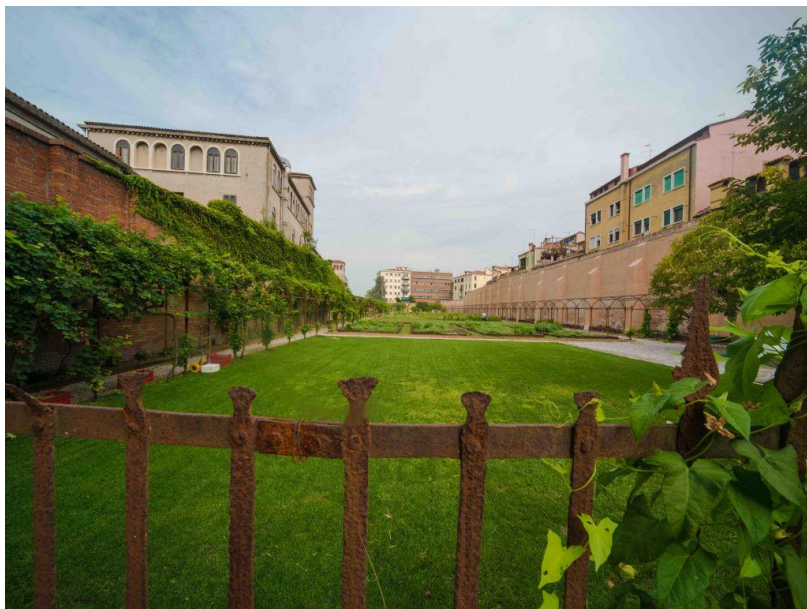

During the afternoon, **it will also be possible to visit the Mystical Garden, led by the Discalced Carmelite Friars**, to discover a unique variety of botanical species, vines and spirituality.

During the day it is recommended to use the mask and to sanitize the hands with the special gel present in the dispensers located in the rooms where the event will take place, in compliance with the most recent *anti-Covid legislation*.

It is also recommended to avoid gatherings at the stands of exhibiting companies.



At the entrance it will be possible to donate € 10, as a responsible offer that will go to the *Discalced Carmelite Friars* (reserved for over 18s, as minors enter for free), while a deposit for the tasting glass will be provided for € 5.

The organizers will have the right to request, if necessary, to show an identity document certifying the majority of age.
